

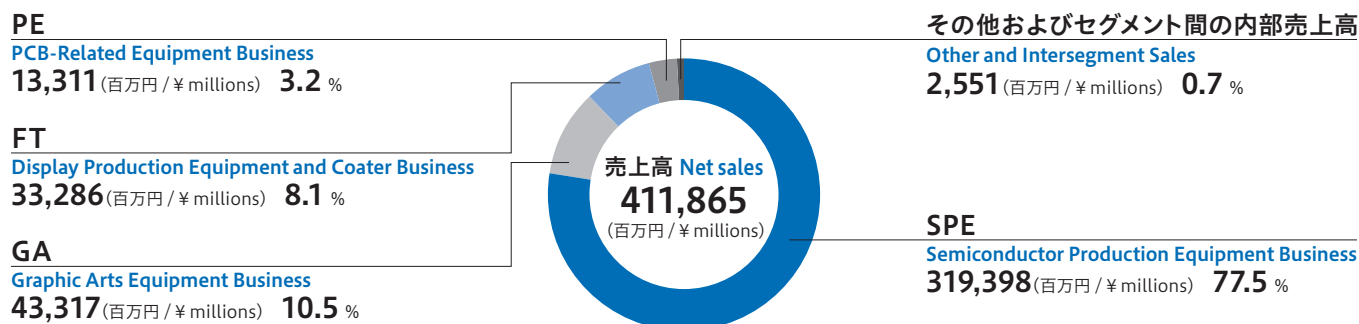

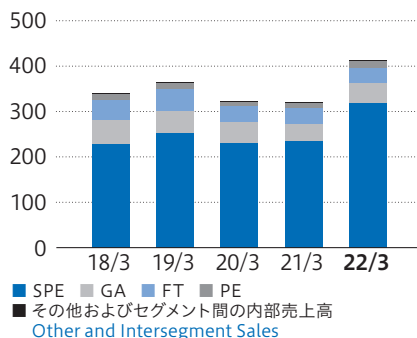

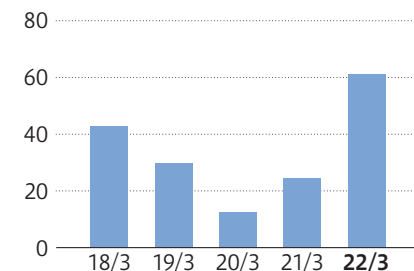
売上高 Net sales

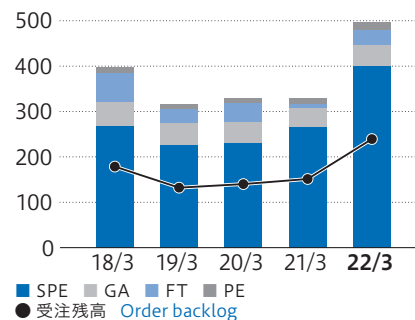
営業利益 Operating income

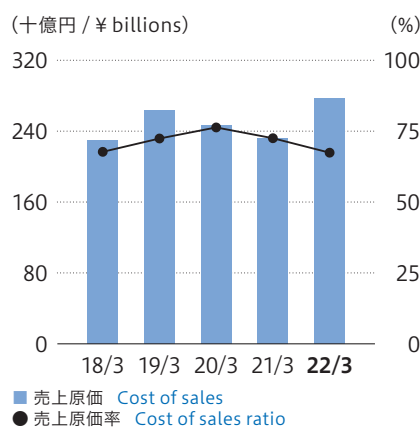

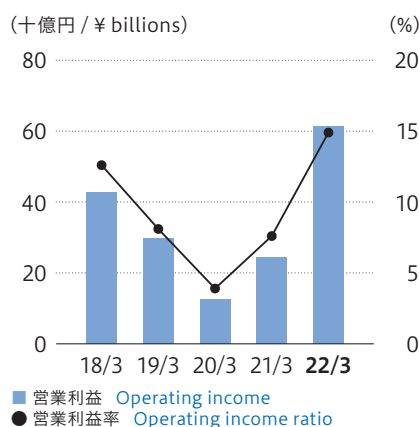

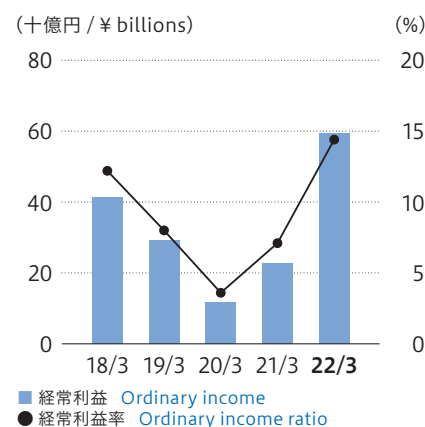

Cost of sales & Cost of sales ratio



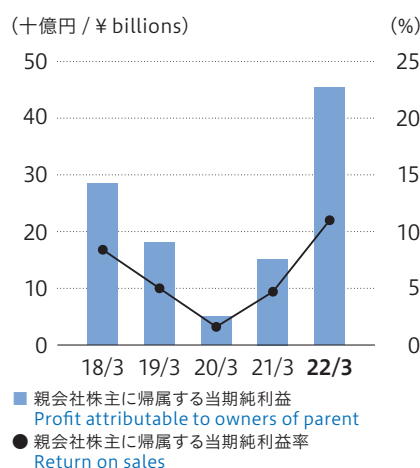

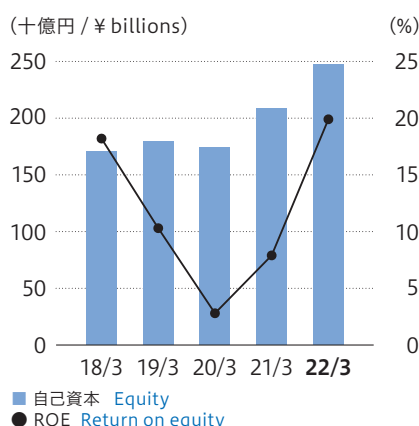

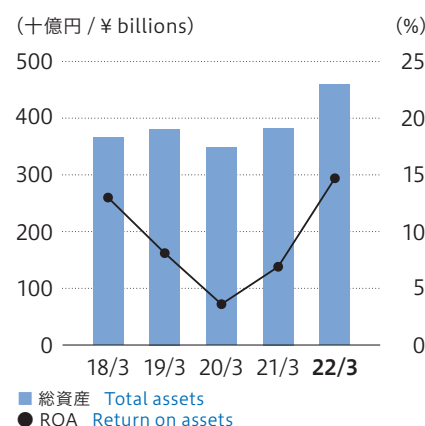

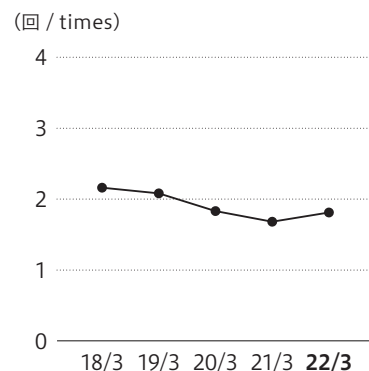
ROI Return on investment



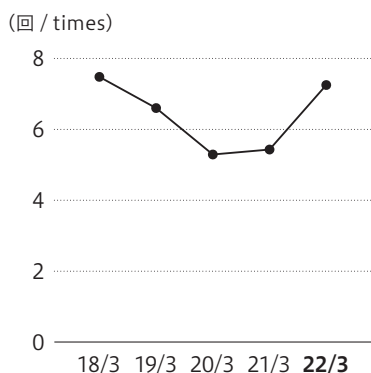

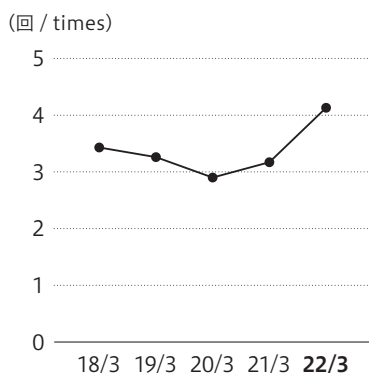

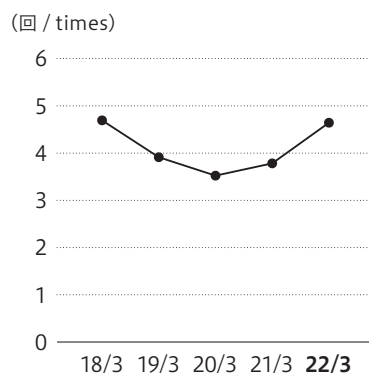
有形固定資産回転率 Tangible fixed assets turnover

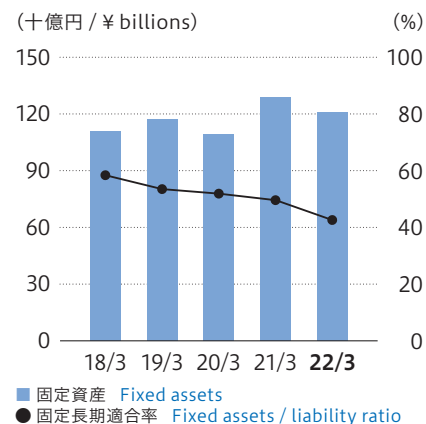

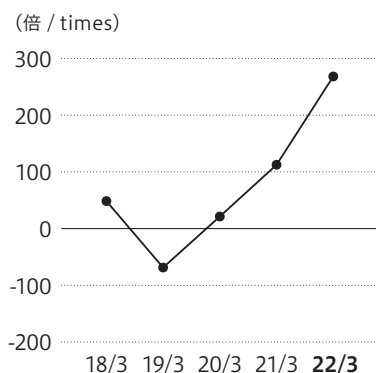

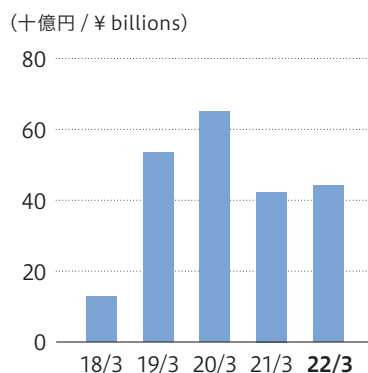

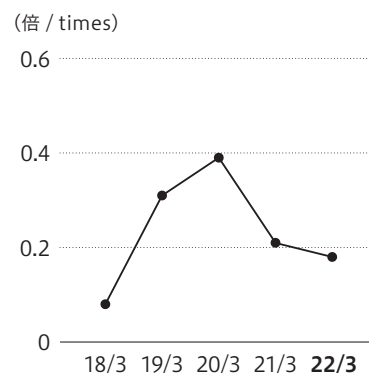

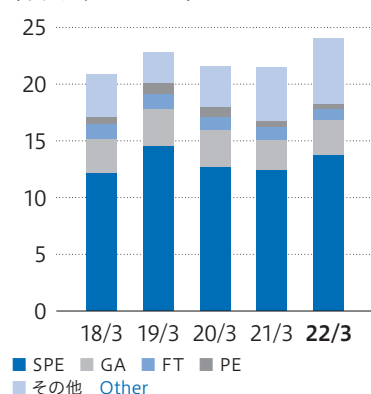

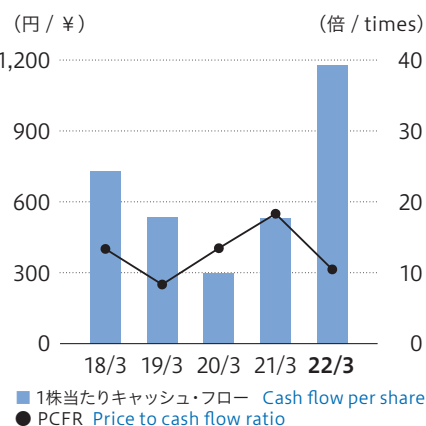
1株当たり当期純利益 & PER Net income per share & Price to earnings ratio



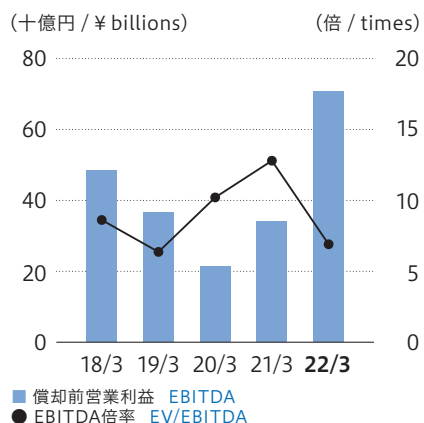
1株当たり純資産額 & PBR Net assets per share & Price to book value ratio



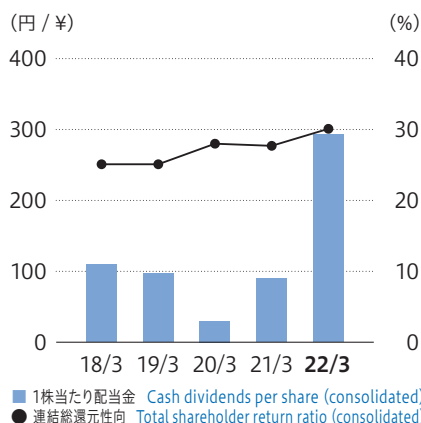
1株当たりキャッシュ・フロー & PCFR Cash flow per share & Price to cash flow ratio

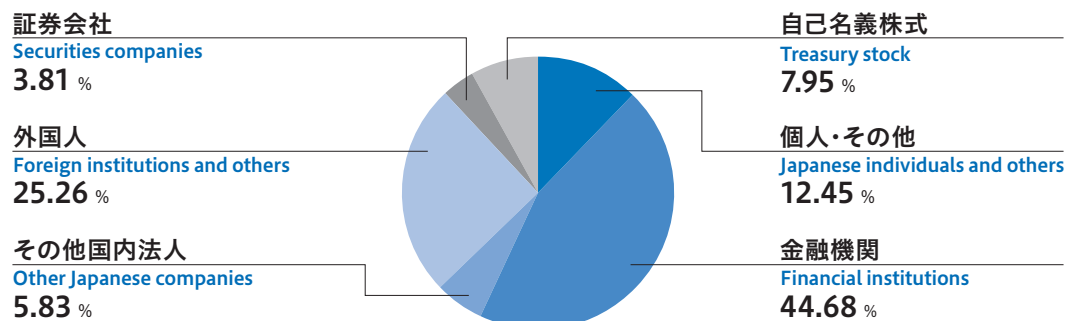

株式所有者別状況 Shareholders Distribution



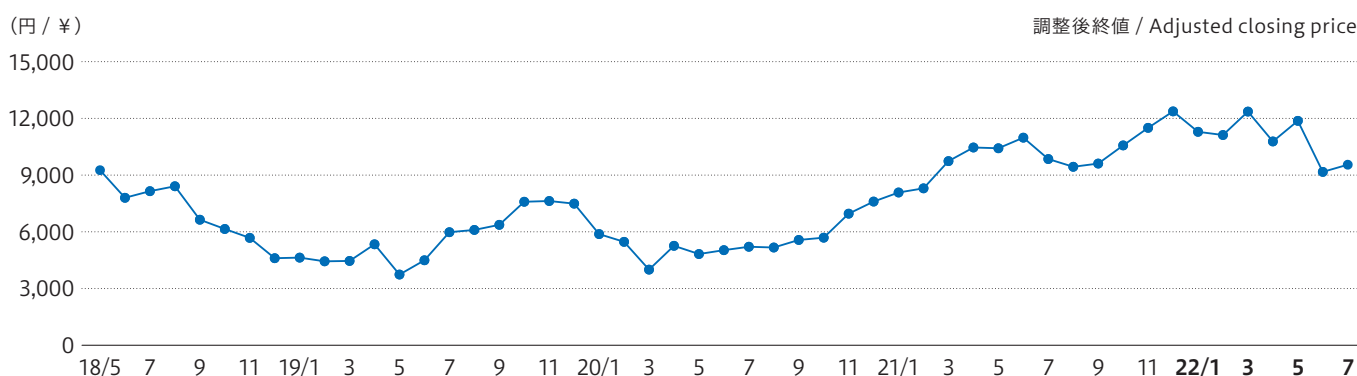

株価推移 Stock Price



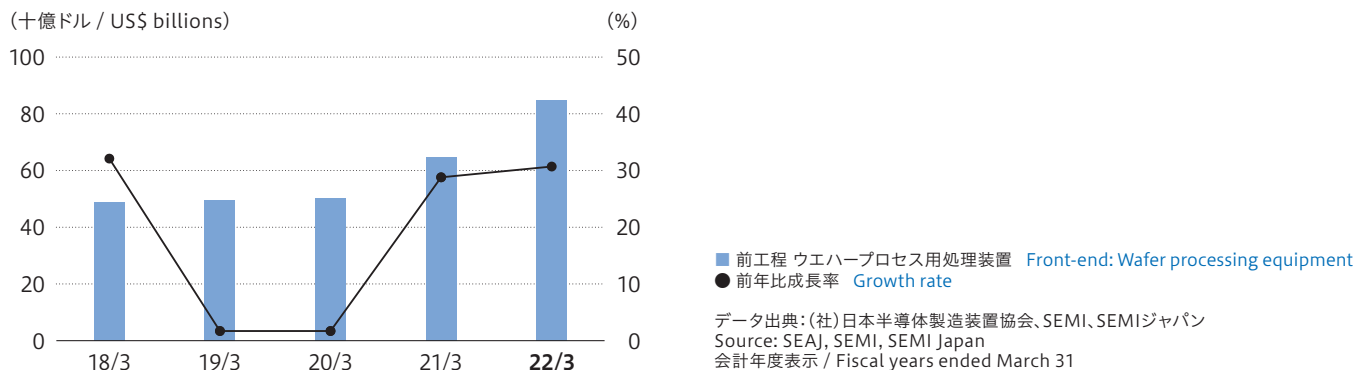

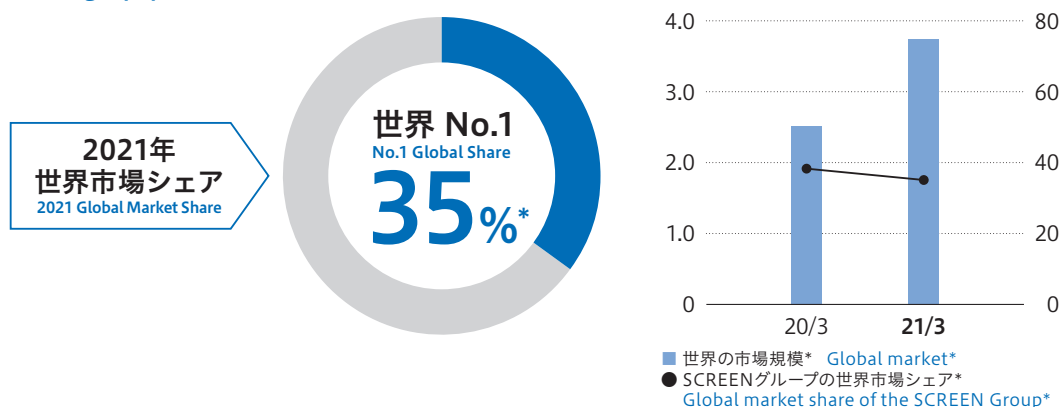

Market for WFE (wafer fab equipment)



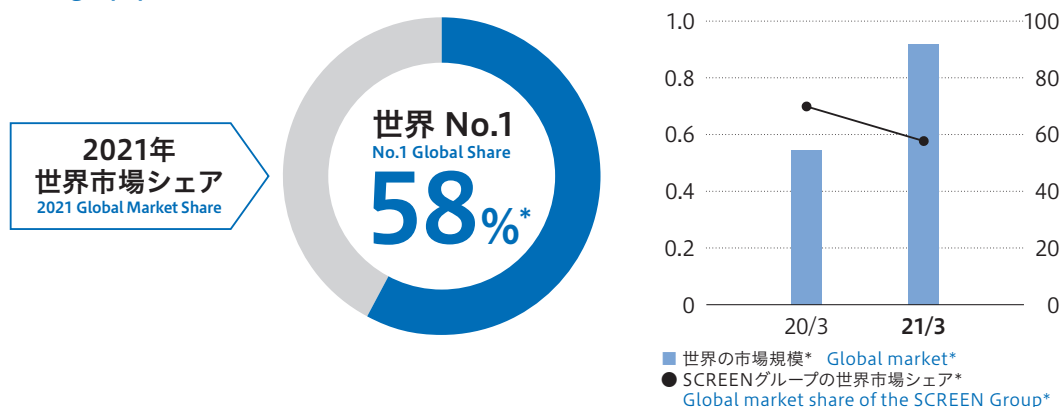
