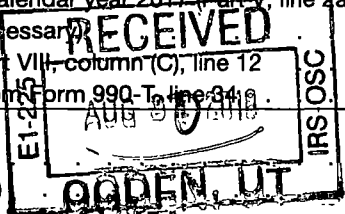

The amendment is as follows: An Executive Committee will be established to act in an interim capacity for the Board of Directors with the authorization to carry out the functions of the Board as provided in Article I (A) (I-7) of the Bylaws. The composition of the Executive Committee shall consist of the Officers as provided in Article II (A) of the Bylaws, and one (1) additional at large Member of the Board as appointed by the then serving Chairperson of the Board of Directors, at his/her discretion. The term of the at large Member of the Executive Committee shall be determined by the then current Chairperson of the Board.
