IN THE CASE OF THE ARMY JROTC LEADERSHIP SYMPOSIUM AND ACADEMIC BOWL, THE AIR FORCE JROTC ACADEMIC BOWL, AND THE NAVY JROTC ACADEMIC BOWL, THERE IS ALSO A FINAL ROUND IN WHICH THE TOP TEAMS FROM THE ON-LINE COMPETITION TRAVEL TO A VENUE FOR A HEAD-TO-HEAD FINAL ROUND TO DETERMINE THE CHAMPION.
