INDEPENDENT AUDITOR'S REPORT

To the Board of Directors

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Civil-Military Innovation Institute, Inc. (the Organization), which comprise the statements of financial position as of June 30, 2024 and 2023, and the related statements of activities, functional expenses and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Civil-Military Innovation Institute, Inc. as of June 30, 2024 and 2023, and the changes in its net assets, functional expenses and cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS) and the standards applicable to financial audits contained in *Government Auditing Standards*, issued by the Comptroller General of the United States (*Government Auditing Standards*). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Organization and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Organization's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and *Government Auditing Standards* will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS and *Government Auditing Standards*, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Organization's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Organization's ability to continue as a going concern for a reasonable period of time.

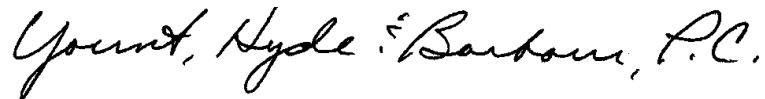

The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated, in all material respects, in relation to the financial statements as a whole.

Other Reporting Required by *Government Auditing Standards*

In accordance with *Government Auditing Standards*, we have also issued our report dated February 14, 2025 on our consideration of Civil-Military Innovation Institute, Inc.'s internal control over financial reporting and our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. Notes to Financial Statements

Note 1. Nature of Operations

The Civil-Military Innovation Institute, Inc. (the “Organization”) is a coalition of academic institution faculty, staff, and students, and outside organizations inside the Department of Defense and the broader national security community. The Institution formed in 2014 to foster innovation through direct and constant collaboration between service members and researchers, creating solutions designed to fit warfighters’ needs from the beginning.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting and, accordingly, reflect all significant receivables, payables, and other liabilities. Accordingly, the net assets, revenues, and expenses of the Organization are classified and reported as follows:

Net Assets Without Donor Restrictions – Net assets available for use in general operations and not subject to donor restrictions.

Net Assets With Donor Restrictions – Net assets subject to donor-imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or other events specified by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both.

Revenue Recognition

The Organization recognizes revenue in accordance with ASC Topic 606. This standard provides a five-step model for recognizing revenue from contracts with customers as follows:

- Identify the contract with a customer
- Identify the performance obligations in the contract
- Determine the transaction price
- Allocate the transaction price to the performance obligations in the contract
- Recognize revenue when or as performance obligations are satisfied

Nature of Products and Services

The Organization’s revenue consists of government grants, contract revenue and other grant income. The Organization’s government grants and contract revenue are contracts which are conditioned upon certain performance requirements and/or the incurrence of qualifying expenses. Amounts received are recognized as revenue when the Organization has met the certain performance obligations and/or has incurred expenditures in compliance with specific provisions.

Notes to Financial Statements

Transaction Price

The transaction price is the amount of consideration to which the Organization expects to be entitled in exchange for transferring goods and services to the customer.

Contract Balances

Funds received by the Organization relating to revenue generating activities of future reporting periods are recorded as deferred revenue on the statements of financial position. The Organization does not recognize revenue in advance of the right to invoice and therefore has not recorded a contract asset at June 30, 2024 and 2023.

Contributions

Contributions, which include unconditional promises to give, are recognized as revenue in the period the promise is made by the donor. Conditional promises to give are not recognized until the conditions on which they depend are met. Contributions of assets other than cash are recorded at their estimated fair value at the date of gift.

Contributed Nonfinancial Assets

Contributed nonfinancial assets are recorded at the respective fair value of the goods or services received. There were no nonfinancial contributions during the years ended June 30, 2024 and 2023.

Accounts Receivable

Accounts receivable represents Federal grant revenue and Federal contract revenue due but not yet received at year-end. Management determines the allowance for doubtful accounts by evaluating individual outstanding balances and based on relevant available information, from internal and external sources, relating to past events, current conditions and reasonable and supportable forecasts. There was no allowance for doubtful accounts at June 30, 2024 and 2023. The opening balance of accounts receivable at July 1, 2022 was \$1,889,357.

Advertising

Advertising and marketing costs are expensed as incurred. Marketing expense was \$69,333 and \$43,427 for the years ended June 30, 2024 and 2023, respectively.

Income Taxes

The Organization is exempt from Federal and State income taxes under Internal Revenue Code Section 501(c)(3). Accordingly, no provision for income taxes has been made in the financial statements.

Allocation Methodology for the Statement of Functional Expenses

The costs of providing program and other activities are summarized on a functional basis in the statements of functional expenses. Certain costs have been allocated among program, management and general. Such allocations have been made by management on an equitable basis. All expenses have been allocated directly by cost except for benefits which were allocated based on time and effort.

Notes to Financial Statements

Cash and Cash Equivalents

For purposes of the statements of cash flows, the Organization considers all highly-liquid investments available for current use with an initial maturity of three months or less to be cash equivalents. The Organization maintains its cash in a bank deposit account which, at times, may exceed federally insured limits. The Organization has not experienced any losses in such account. The Organization believes it is not exposed to any significant credit risk on cash and cash equivalents.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Intangible Assets

Intangible assets represent intellectual property purchased by the Organization. The assets are stated at cost. Amortization is calculated using the straight-line method over the assets' useful life of 15 years.

Property and Equipment

Property and equipment are stated at cost or, if donated, at the estimated fair market value at the time of donation. Depreciation is calculated using the straight-line method over the assets' useful lives as follows:

Furniture and equipment	3 - 10 years
Vehicles	5 years

Note 3. Liquidity and Availability

The Organization had \$20,060,421 and \$14,948,600 of financial assets available within one year of the statement of financial position date to meet cash needs for general expenditure as of June 30, 2024 and 2023, respectively. The Organization has a policy to structure its financial assets to be available as its general expenditures, liabilities and other obligations come due.

Note 5. Leases and Subsequent Events

The Organization leases office and storage space under various operating lease agreements. Renewal options are considered and included in the lease terms only when it is reasonably certain that the Organization will renew the lease in the future.

During the year ended June 30, 2021, the Organization rented office space for \$2,000 per month. On August 1, 2021, the Organization renewed the lease agreement through July 31, 2025 for monthly payments of \$5,000 per month. On February 1, 2022, the Organization entered into a separate lease agreement for additional space in the same building through January 1, 2025 for monthly payments of \$10,000 per month. The lease renews for an additional two years through January 31, 2027.

Notes to Financial Statements

On September 23, 2021, the Organization entered into a lease agreement for storage space and the lease has been renewed through September 22, 2025 for \$1,100 per month.

On May 1, 2022, the Organization entered into a lease agreement for office space and the lease was renewed through April 30, 2024 for \$275 per month. The lease has been terminated as of November 30, 2024.

On July 13, 2022, the Organization entered into a lease agreement for office space and the lease has been renewed through July 17, 2025 for \$400 per month.

On December 1, 2023, the Organization entered into a lease agreement for facilities through December 31, 2024 for \$10,000 per month. The lease has been renewed through December 31, 2025.

On June 5, 2024, the Organization entered into a lease agreement for office space through June 1, 2025 for \$3,659 per month.

On August 2, 2024, the Organization entered into a lease agreement for office space through August 31, 2044 for \$29,920 per month.

On September 8, 2024, the Organization entered into a lease agreement for office space through November 30, 2025 for \$8,730 per month.

On October 23, 2024, The Organization entered into a lease agreement for office space through October 31, 2034 for \$2,000 per month.

Total rent expense was \$292,765 and \$195,779 on these agreements during the years ended June 30, 2024 and 2023, respectively. As of June 30, 2024, the Organization's weighted average discount rate was 3.49% and weighted average remaining lease term was 2.49 years. As of June 30, 2023, the Organization's weighted average discount rate was 2.88% and weighted average remaining lease term was 3.7 years.

Note 7. Notes Payable

On September 2, 2021, the Organization entered into a loan agreement of \$57,383 to purchase a vehicle. The loan requires monthly payments of \$1,131 with an interest rate of 4.9% and matures in September 2025. The balance was \$19,202 and \$33,765 at June 30, 2024 and 2023, respectively.

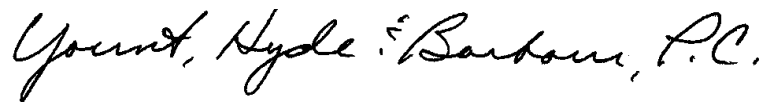

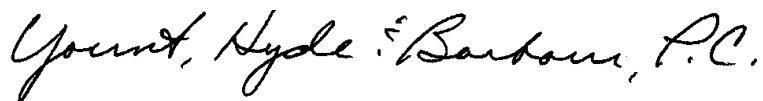
